### Police Rep./C.O.P. – Dave Powers

**Crime in Chartley-** 3 crimes were reported by Chartley residents *dur*ing January. Two of these were non-domestic assaults and the other was a domestic assault. The first non-domestic assault was reported in the 500 Blk of Deacon Brook Cir on Jan 12<sup>th</sup> at 8:06 PM and the other was reported on Jan 17<sup>th</sup> at 12:58 PM in the 00 Blk of Glyndon Ct. The domestic related assault was reported on Jan 29<sup>th</sup> at 11:29 AM in the 400 Blk of Deacon Brook Cir.

- Note: Please note that in the 3 crimes reported in January, the Crime reporting websites that I use to track crimes provided the time that the report was called in to 911. This was discontinued in Sept 2020, but it looks like this has been reinstated, If it continued, it will be a great help in determining crime patterns.
- Note: Jan 12-Assault reported 8:06 PM, 500 Blk Deacon Brook Cir-follow up with police revealed that the call was for the area of 510 Deacon Brook Circle It was a call for a suspicious condition...resident said it looked like several people in a vehicle were fighting or arguing. Called police...when police got there, subjects took off running...vehicle was determined to be stolen out of Westminster. K9 unit deployd which tracked suspect down Glen Granite Rd, exiting onto Gwynwest Rd. Unable to track suspect beyond that point. Unsure if there are any arrests as of yet.
- Note: Assault reported 11:29 AM, 400 Blk Deacon Brook Cir-Domestic related
- Note: A number of crimes (e.g. assaults, burglaries, and thefts) were reported in the Chartleytowne apartment complex during January...and for the preceding months). These types of crimes were also reported during the same time frame in the 11000 and 12000 blocks of Reisterstown Rd, and in the 00 Blk to the 600 Blk of Main Street during the same period. The level of crimes being reported in the Chartleytowne Apt complex has been growing at an alarming rate...enough so that I have heard that residents of Chartleytowne are, once again, trying to form their own COP Program but are running into resistance from management. If this rate of crime continues to increase thru February, I may have to go and sit down with them to express our concern as these crimes may spill out into Chartley. Before I do that however, I want to discuss the situation with Capt. Jamerson to see if the police will review the situation and talk to Chartleytowne property management first.
