Approval of August and September 2023 Board Meeting Minutes – Mary called a motion to approve meeting notes, Dave 2nd all approved.

Police Rep./C.O.P. – Dave Powers

Crime in Chartley- 1 crime was reported in Chartley during September which was a non-domestic assault reported on 9/26 in the 200 Blk of Highmeadow Rd.

YTD total now stands at 16, 9 of which have been thefts, 2 burglaries, 3 non-domestic assaults, and 2 reported cases of vandalism.

- There was a burglary reported in the 500 blk of Gwynnwest Rd on Sept 2nd where 5 suspects broke into a residence there. Follow up with the police revealed that the incident occurred at 533 Gwynnwest Road. It was basically an assault between juveniles where known suspects entered house through open rear door and beat up the granddaughter. Nothing random about it. The disposition of this case is unknown at this time.
- There was a reported non-domestic assault on 9/16 in the 200 blk of Arms Chapel Rd. Follow up with the police indicated that this was actually a case of simple phone misuse which was mis-classified.

PCRC Meeting Sept 19, 2023

- **Capt Jamerson's report:**
 - Increase in shoplifting throughout the precinct
 - Increase in auto theft and attempted auto theft throughout the precinct. This includes an increase in smashing windows to gain access to the vehicles. Most of this increase has been perpetrated by juveniles. One juvenile under 13 has been arrested 11 times, but, due to the existing Md Juvenile Justice Reform law passed that went into effect July 1, 2022, except in certain specific cases, the police must release all juveniles under 13 without questioning them unless in the presence of an attorney, or the youth's parents.
 - a. During the recent cool spell, 2 vehicles have already been stolen while the owner was warming it up unattended.
 - Theft of wheels starting to increase, particularly for Honda vehicles, but also starting to affect Toyota vehicles.
 - One arson case in precinct since last PCRC meeting in June (Advanced Auto in the Reisterstown shopping center. Employee arrested.
 - No homicides in Precinct this year so far.
 - The Newtown area is slated to have a license plate reader as soon as funding is available.
 - Baltimore County currently short approximately 250 officers.
